Specialised inspection programs aligned with AS 3788 and international codes detect degradation, ensure compliance, and extend asset life while mitigating environmental and safety risks.




Conventional Non-Destructive Testing

In-depth material investigations for compliance, material selection, and root cause failure analysis to support asset integrity, repairs, and incident prevention.




Heavy Machinery Inspection
